Care Management

Care management applies to all clients receiving services under all Support at Home classifications. This includes self-managed clients who require a base level of care management in order for the provider to meet their obligations.

Care Management involves initial and ongoing:

- · Care planning
- Service planning and co-ordination
- · Development, review and evaluation of care plan and quarterly budget
- · Monitoring of services provided
- · Provision of information and education about the clients care and services.
- Support to connect to health and other services when needed
- · Assistance to undergo a Support Plan Review as required

Self Management

Anglicare At Home offers clients the option to self manage aspects of your Support at Home Package. This allows you to select your own care workers, determine the times and days of your service, and source suitable products and equipment to help you maintain your independence at home.

As your provider, Anglicare remains legally responsible for ensuring your care workers are suitably qualified, can deliver safe and high-quality services, and meet our compliance requirements.

There are benefits to self-managing, but it also places more responsibility on you to coordinate and source services. It's important to carefully consider whether this option is right for you.

Services need to be approved by your Care Partner to ensure they fit within your SAH budget.

When self-managing, you will typically use a platform-based service (e.g., Mable). These platforms allow you to agree on pricing for each service, with billing based on the agreed amount (inclusive of GST) plus a 10% administration fee.

When Anglicare Staff are engaged to carry out services you will be charged the Support At Home Package Fees, when using a third party you will be charged at the Associated Provider Fees where applicable.

Associated Provider

Giving you choice is important to us. We understand that you might prefer to use your own supplier (non-Anglicare staff) to deliver your care services. Where this occurs, services provided by your nominated contractor will be charged in accordance with the fee schedule outline in this schedule. All other goods and services provided by third parties including other therapeutic services e.g.: chiropractic & remedial massage, property modifications and maintenance will be invoiced at an agreed amount including full invoice amount including GST + 10% administration fee.

Cleaning Partners

In addition to our internal care staff and your nominated service providers, we also offer services through our approved cleaning partners. These services will be charged at a fixed rate of \$99.00 per hour and available Monday to Friday standard business hours (minimum of 1 hour service).
