Terms & Conditions

- 1. 1 hour standalone services are available on request.**
- 2. Overnight Active or Inactive (Sleepover/Respite Care):** Please contact us for overnight fees if required.
- 3. Service Alterations/Cancellations:** Prestige requires 24-hours' notice for cancellations, otherwise full-service fee will be charged.
- 4. Aids/Equipment:** Prestige may pay or receive commissions for equipment/aids that we recommend or provide. All quotes are inclusive of any commissions.
- 5. Transport Services:** Rates start at \$157.44 per trip.
 - All other services listed in the fee schedule include ad-hoc travel up to 3km.
 - Please request a copy of our full price list if you require additional accompanied activities services greater than 30km.
- 6. Care Management:** charged at \$157.80 per hour in 15 minute increments. Clinical Care Management from \$198.30 /hr.
- 7. ATHM administration fee applicable on all ATHM invoices:**
 - Assistive Technology Fee: 10% of the total cost, or up to \$500 (whichever is lower).
 - Home Modification Fee: 15% of the quoted costs or up to \$1,500 (whichever is lower).
 - Co-ordination and Prescription fees may payable for AT&HM Services.
- 8. Nursing Services:** Rate above is for standard nursing services, complex nursing service are a quoted service.
 - Nursing services include basic clinical consumables, anything outside of this will incur an additional fee.
- 9. Allied Health & Associate Providers:** Services will be coordinated by Prestige and provided via our Approved Service Provider Partners. Service prices will be discussed and agreed at the time of booking. Prestige may apply an administration/processing fee of 10%, this will be incorporated into the total amount quoted.

Care Management includes the Initial Assessment and complete establishment of your Care Plan and ongoing care needs, care co-ordination, as well as ensuring services are aligned with care goals. The Care Management Fee is based on a percentage of the available government subsidies and the fee may increase in line with subsidy increases. If the subsidy changes over time, so too may the package management fee and care management fee.

Hours are approximate and based on weekday 2-hour minimum domestic assistance rate, and will vary based on day of the week, services required or public holidays.
