Please note the following information:

- Standard weekday rates are Monday to Friday, 6am to 8pm
- Standard weekday evening rate are Monday to Friday, 8pm to 6am
- There is no charge for carers to travel to and/or from your service
- Reoccurring services are provided on a weekly basis
- Domestic Assistance Services are generally scheduled after 11am each day
- We generally require 48 hours notice for ad hoc services to be scheduled, however we will endeavour to fill all requests.
- GST does not apply to Support at Home services provided by our staff, however GST may be chargeable on services provided by third-party suppliers requested by clients
- Cancellation Policy: Cancelled services remain billable if the request is made less than two days prior to the service. Cancellations due to unplanned hospitalisation are exempt from this notice period requirement
- Our Prices may increase up to twice per financial year if we provide you with at least 14 days' notice of a change. If we notify you of a change, our fees and charges will increase by an amount up to the greater of 5%, any increase in CPI, and any increase in the average wages of personnel concerned with the provision of home care under an applicable award or industrial instrument (since the last review or if there has been no prior review, the Start Day).
- Any changes will accord with the Aged Care Act and Rules.
