Service Descriptions

Care Management

Care Management may include:

- Reviewing the Home Care Agreement and Care Plan
- Coordination and scheduling of services
- Ensuring that the care we provide is aligned with other supports
- Providing a point-of-contact for the client or their support network
- Ensuring that the care provided is individualised to the client, their culture and their choices
- Identifying and addressing risks to the client's safety.

Package Management

Package Management is the ongoing administration and organisational activities associated with ensuring the smooth delivery and management of the Home Care Package.

It may include the costs for:

- Preparing monthly statements
- Managing your package funds
- Compliance and quality assurance activities required for Home Care Packages
- It does not include costs that are unrelated to supporting the client's care, nor costs associated with the QRC's running of their business such as marketing, office rent, insurance, or activities completed before the client enters into a Home Care Agreement with us.

- **Brokerage fees**
- QR Carers will charge up to \$250.00 to set up an Agreement with another provider such as podiatry, physiotherapy, gardening, etc. This fee covers the costs involved in
 - checking that they have all the required insurances,
 - that they are qualified to provide the required service,
 - that they hold any necessary licences or registrations and
 - that they have a current criminal history screen.
