The following service details and price list are based on guidelines and information such as the Aged Care Act and the support at home handbook, effective January 20th, 2025.

This price list is subject to change due to new government price changes, including wage increases for employees and CPI increases. Furthermore, prior to the release of new national policies on 01/07/2026, it may be subject to change at any time based on recent developments and company policy adjustments.

Care Management

The government has automatically set aside 10% of your quarterly budget for Care Management.

There will no longer be package management fees. Moving forward, our services for case management will be charged at an hourly rate. We claim your Care Management portion from your dedicated funding pool.

Assistive Technology (AT)

Assistive technology includes items, pieces of equipment or products that help a participant to do things more easily or complete activities they can no longer do independently. The following Table includes key funding allocation for assistive technology:

Participants who have assistive technology costs above \$15,000 can access additional funding with evidence, such as a valid prescription.		

As a provider, we have administration costs which many include liaising with assistive technology suppliers, purchasing low risk assistive technology products and equipment, and organising quotes delivery and paying

Our administrative fee for assisting with technology delivery is 10% of the total cost, or a maximum of up to \$500 of the invoiced amount (whichever is lower).

Home Modifications (HM)

Home modifications provide changes to a participant's home environment to make it safer and more accessible. Table 13 Below details funding allocation for Home Modifications.

Table 14: Home Modification Funding – is part of the Independent Care Service

Funding may be extended for an additional 12 months to complete complex home modifications (24 months in total) if evidence is provided to Services Australia.		

As a provider, we have coordination costs in project management of your home modification, including organising quotations, communication with local government for structural modifications and managing subcontractor invoices.

Our coordination fee is 15% of the quoted price, or a maximum of up to \$1,500 (whichever is lower).

Surcharge for Independent, Third-Party Suppliers

Under the Aged Care Act, we will apply a 10% surcharge for services you yourself source from a third-party provider. This can only be negotiated and determined under communication with your care partner, and the prevailing conditions of the client agreement is satisfactory.

As client who choose “Self-Selected Service Provider”

(if you do not wish to use the supplier as TSCG provided, then)

You (participant) are willing and encouraged to independently select any "third-party" service company or sole trader provider to provide you with relevant services and products you prefer.

You agree on that you will arrange the service or product and you will pay for the invoice before you get reimbursed (by service Australia).

TSCG (The Provider) and You (participant) both agree on the service price for third-party workers that will be charged to you the participant's budget. Consideration of the final self-selected service price should include the overhead admin and processing fee 10%, generally, services delivered to a participant using a third-party worker are inclusive of GST.

You may be required to contribute to your services and product needs depending on your income test fee. The current home care subsidy amount is published on the Australian Governments website.

Reimbursements and participant contributions

Participant contributions apply for all services delivered in the independence and everyday living service categories. Whilst there are no contributions for services in the clinical supports category as clinical care is fully funded by government for all participants. The price paid by the participant at the point of purchase will include both the government subsidy and the participant contribution (if a contribution is applicable).

TSCG will work with you (participant) to determine and document which your contribution will be paid under a reimbursement arrangement.

TSCG will initially reimburse you for the full cost of the service and invoice you for your contribution as per the usual invoice cycle. Alternatively, TSCG will only reimburse you for the government subsidy amount.

Notice Period for Cancelling Services

You must notify us at least two business days in advance of any cancellation or suspension of services (except in emergencies). A business day is a day that is not a public holiday or weekend. Notices received after 4:00 PM on a business day, or on a public holiday or weekend, will be deemed received on the next business day (unless otherwise provided in the Aged Care Act).

Interest Charges

If you are subject to a self-contribution fee and do not pay your contribution by the due date, you will be subjected to interest on the debt owed and we will charge at the current interest rate per the RBA.
