- Transitioned HCP care recipient: A Home Care Package recipient who transitioned to Support at Home on 1 November 2025. This also includes older people who were on the National Priority System prior to 1 November 2025 but had not received a Home Care Package.*

- Grandfathered HCP care recipient: A Home Care Package recipient who, on 12 September 2024, was either receiving a package, on the National Priority System, or assessed as eligible for a package. Grandfathering arrangements only apply to participant contributions and primary supplements.*
