### **Care Management\***

Care management is a mandatory service. As part of this service, Beata Homecare will:

- regularly assess your needs, goals and preferences
- review your home care agreement and care plan with you
- ensure your care and services align with other supports
- partner with you and your family or carers about your care
- ensure your care and services are culturally safe
- identify and address risks to your safety, health and wellbeing

### **Package Management\***

Package management is a service that supports delivery of a Home Care Package, and cover administrative activities that Beata Homecare does, such as:

- establishing and managing home care budgets
- coordinating and scheduling services and workers
- preparing invoices and monthly statements
- complying with regulatory and assurance activities

### **Basic Daily Care Fee**

Home care providers may ask the consumers to pay a Basic Daily Care Fee to add to the available funding of your package.

Beata Homecare does not charge the basic daily care fee.

### **Income Tested Fee**

Services Australia will determine if you are required to contribute to your Home Care Package through an Income Tested Care Fee based on your income assessment. The amount of the Income Tested Care Fee is also determined by Services Australia, and you will receive a letter from Services Australia with this information. Beata Homecare will charge the Income Tested Care Fee according to Services Australia’s assessment. Invoices for Income Tested Care Fees will be sent monthly.

- All above prices are exclusive of GST.
- A minimum of 24 hours' notice is required for cancellation of a service, otherwise the full rate for the scheduled service is charged.
- Care staff will require a 30minute break for any services exceeding 5 hours. Staff cannot supervise or assist a client during their breaks. You will not be charged for the break time.

## Light Gardening

This may include lawn mowing, light pruning, weeding, and minor garden maintenance. Prices are subject to the requested job and can range from \$65 to \$77 per hour.
