Support at Home Prices

Our prices are current from the commencement of the Support at Home program on November 1st, 2025. These prices relate to Support at Home program which are government funded, they do not include prices for CHSP or private rates.

You may be asked to pay a contribution towards the cost of some services. Contributions are calculated as a percentage of the service cost. The percentage will be different for each participant and will be based on an assessment by Services Australia of your income and assets. You will only pay for the services you receive. If you do not provide your income and assets information to Services Australia, you will be a 'means not disclosed' participant, and your contributions are set at the maximum level.

Your out of pocket costs (if you are assessed as required to pay contributions by Services Australia) are listed underneath each category of support.

During your first free consultation an experienced team member will sit down with you and your family to come up with a personalised care plan. This will include a customised combination of the services on this page.

If a Market Price is shown, we will provide a quote and discuss the service with you. Grandfathered HCP care recipient

A grandfathered Home Care Package is a recipient who, on or before 12 September 2024, was either receiving a package, on the National Priority System, or assessed as eligible for a package.

Transitioned and grandfathered HCP care recipients may pay a contribution rate (if required). For participant contributions, a no worse off principle applies for grandfathered HCP care recipients. These participants will make the same contributions, or lower, than they would have had under HCP program arrangements, even if they are re-assessed into a higher Support at Home classification at a later date. They will no longer pay an income-tested care fee as this was abolished under Support at Home.
