Care Management

10% will be deducted from your Support at Home classification budget per quarter for Care Management.

Care Management helps you stay independent at home by making sure your services are well-organised, safe, and suited to your needs. A care Coordinator will check in monthly, update your care plan, and support you with any changes or concerns.

Participant Contribution

Under the Aged Care Act 2024, the Government fully funds Clinical Support services. However, unless you have been receiving, assessed for, or assigned a Home Care Package (HCP), you may be required to contribute to the cost of Independence and Everyday Living services. The exact contribution amount, if applicable, is determined by an assessment of your income and assets conducted by Services Australia.

Cancellation

FOCUS Connect requires a minimum of 48 hours' notice for cancellations or temporary suspensions of scheduled services. For cancellation of services less than 48 hours, you will be charged the full-service cost.

Minimum hours of service

FOCUS Connect provides a minimum of 1 hour for personal care, 1 hour for clinical support and 2 hours for all other service types.

Price Increase or Adjustments

We will give you at least 14 days' written notice before any new prices take effect. All price changes will be consistent with the Aged Care Act and Rules. Our prices may be subject to price increases having regard to the cost of delivering services.
